

EQUESTRIAN MOVEMENT FOR VAULTERS

# **General Information**

The place of location for the training device MOVIE is crucial for its safe use and longevity. To ensure your safety, the following conditions apply to the training room:

- The MOVIE must be placed on firm ground. Riding hall floor (sand) is unsuitable.
- A two-meter safety distance is required in all directions between MOVIE and walls.
- The height of the training room depends on the purpose of use. Individual vaulters need at least 2,5 m above the top line of MOVIE (4 m high ceiling), and vaulting squads require 4,5 m above the top line (6 m high ceiling).

The following conditions must be observed in order to maintain the guarantee:

- The place of location must remain frost-free throughout the year. Exposure of the training device MOVIE to temperatures below freezing is not permitted.
- The exposure to humidity should be moderate. Gymnastic halls and other enclosed spaces are considered as standard. Stables, riding halls or outdoor areas are not suitable. Extended exposure to increased humidity will void the warranty.
- The training device MOVIE has to be protected against excessive dust.

# **Design Options**

- Height: between 115 cm and 145 cm
  (This choice depends primarily on the ceiling height of your training facility. The taller MOVIE is the better choice for advanced vaulters that like to train ground jumps as well, whereas the small MOVIE offers better conditions for the trainer to assist technically difficult elements. Please contact us if you require further information on this topic.)
- Or **Colour:** Beige, dark brown and black are our standard colours of upholstery. Depending on availability, we also offer other colours.
- Head / Neck: It is possible to order a horse's head-shaped element or a short neck element. The short neck element is advantageous when it comes to giving support while swinging into a handstand (scissors and flank), since the head-shaped element might obstruct the trainer.

> The purchase is possible worldwide. Outside the European Union (EU), 19% VAT may be deducted from the purchase price, provided that it is accompanied by a certificate of export duty.

When selling to private persons within the EU, the gross price is to be assumed. Associations and companies may present a tax number to pay the net price only (reverse charge).

## **Rent Information**

For legal reasons, the rental option is offered only within Germany. The rent is to be paid beforehand every month. The vaulting surcingle for the training device MOVIE is included for the rental period. The conditions are determined in the renting contract.



## Long term rental

250 EURO / month (duration longer than 12 months)



## **Event rental**

100 EURO / 1. day – additional days 100 €/day for a period of eight days and more, the rent is € 60 per day

All rental options require a deposit of 500 EURO.

# **Further Information**

- Placing the MOVIE inside the riding hall might be allowed for short-term events (event rental), but this type of application should always be discussed with us.
- Ouring any access and operating time of the MOVIE in both cases of purchase and rent, trained care personnel (of legal age) must be present. When no supervision is present, the MOVIE must be made inaccessible for safety reasons (removal of the remote control).
- O The handling of the device is explained in a briefing given by our staff at time of delivery. It further is explained in the instruction manual.
- O Careful handling is expected while using the rental MOVIEs.

# **Time of Production & Transportation**


The delivery time after purchase is typically two to three months. We are happy to discuss the current production situation in a personal communication. Our rental MOVIEs are available immediately upon request and availability.
